- Reproductive and Gender Affirming Bill passed and signed by gov
- Protections to Providers and recipients passed and signed by Gov
- Affirmative Consent died in the house. Ran out of time. Girls' from Capital High, this bill was a key initiative.

Rachel

Behavioral Health Wins

- Passed both houses and will probably be signed.
- Authorization for crisis triage centers. Including funding and capacity. This is where police can take people but there aren't a lot of them. Mostly in SAF, ABQ and Las Cruces
- Mental health parity bill prohibits any insurer from having lower insurance than others.
- Authority to fund school based health centers across the state. Kids who had experience from a school based health centers are more likely to take advice from adults.
- Behind these bills are Jerry Ortiz Y Pino work on behavioral health needs powerful people. He is very progressive.

Immigration Front

- Bill to create a division of state agency for economic development from oil and gas jobs. Nathan Small got %50M for transitions. This will help authority for getting things going.
- Angelica Rubio put most of her jr. money to study gig workers etc. Got passed as a bill
- Bill to prohibit immigrant detention did not make it. Get rid of private detention. Senate leadership was not on the floor so it didn't pass. 18-21.

Climate

- Passed renewable energy office in Richards Garcia space
- Passed SB 53 storage radiation waste
- Passed \$100M allocated for legacy fund

Police Academy

SB19

- We wrote an airtight bill. Atty Gen COS said it was a well written bill. So did Peter Wirth.
- Accountability, training, oversight.
- We got identified as a priority bill from the beginning.
- Moe Maestas stepped up to sponsor it.
- It was selected to go to Judiciary to speed it up.
- Joe Cervantes: they needed a LE bill, because of all the crime. But they wanted and hoped to make it bigger.
- There was nothing else except SB 252 Pope and ACLU. All LE was against it. Sen Pope new legislator.

- Judiciary committee heard about SB252 and suggested combining the bill. Once they said that, Clear they were going to do that. They waited until it was too late.
- Stripped sections out of the bill. Maestas let it go. Added stuff from Pope's bill.
- Left in consequences for non reporting but they took out all the requirements for reporting. They did it last and in a rush.
- The Judiciary committee was having trouble with a quorum.
- Rachel threatened to pull the bill. DPS begged her not to do this. It's a foundation.
- Everyone attached stuff New Municipal league, NM county had stuff to the bill.
- Passed with Senate w/o discussion. This bill had no single public hearing.
- Fix every five years stripped out. Modernization stripped out.
- Sections 4 had the Standard & Training Council stripped out re directions. Would have modernized, best practices and modern standards.
- Section 9 reporting of data Popes' requirement of who has going back data.
- The telecommuniators get their stuff.
