- SB19The saga continues. No new news. Senate and house met all weekend. Not seen yet to see promised committee sub.
- Everything proposed by Bill Reim has been tabled. Things we would have had worked to kill was killed by the legis. Pre-trial rebuttable was killed.
- Pre-trial detention going forward
- SB252 use of force. It isn't going to go anywhere but we might be stuck with something on SB19
- Constitutional revision bill going fast. Meet for two years and recommend changes from top to bottom. It's in House J to House fl to being done.
- Civil rights office for ATTY Gen. Last Cervantes bill. Going to Sen Judiciary. Passed House and Public yesterday
- Crime reduction act this will go through.
- Expansion of human rights act has pass house and in Senate has a good chance.
- Corrections Advisory is on house calendar now.
- What's going on? Some bills are not moving. Dummy bills are for omnibus bills. This is what happens to save bills.
- Somos immigration bills two Senate bills in Judiciary prohibits immigration detention in NM which would put the private prisons out of business
- Another under the radar SB 229 immigration classification of children who arrive at the border without parents. Provide protection by the state. Avoid detention.
- HB 188 creates a transition office in development department. Others are trying to stick the bills. HB 215 unemployment benefits for undocumented and gig workers. Stuck in house appropriation committee.
- Senate Judiciary committee is a funnel. A lot of things stuck there. They are not posting a lot, hearing a lot of bills, a bunch of gun bills. Something to watch, sjc.zoom@nmlegis.gov This goes to the staff and reports to Cervantes.

Health

Nancy Rodriquez: second chair for senate finance

- Heatlh SB 265 Study Medicaid Managed care structure. Fund a fund a study of medicaid structure. And consider alternative approaches to the almost half of New Mexicans of Medicare for Shelter, Food, etc. Going through House and Senate together.
- SB7 to make rural HC better passed on 1-31. Now nothing.
- SB290 and HB 293 Last year there was junior money to do study. Went to Dept of Insurance and never did a study. In the absence of Lundstrom they are not calling it Health Security looking at costs.
- Housing trust fund \$. Multi-generational and zoning have all passed one committee. And pass first week of Feb and not listed for hearing. Rachel suggests looking at the latest version of HB2. Sometimes they strip the appropriations from a bill and stick the money into HB 2. Probably get killed a proposal for housing dept. Right now \$ for affordable housing goes through a state authority. There's a lot of things about housing needs and state. Idea to have a dept for overall housing planning, etc. They pulled the housing trust fund control and put it in this housing bill. They should have just given Housing Dept more authority.

Economic justice - nothing on Universal Basic Income

- Rachel says that some of the bills being popular go dark because they are being worked behind the scenes.
- HB 144 increase the child income tax for kids would be more progressive.

- HB12 died. Will revive HB 188 is a good bill. Creates and funds an office to fund projects for people affected by uranimim disaster. Or known things like closing San Juan Generating plant. What we do know about Hydrogen she has staff of about 10 or 12 people getting applications for HHub. She is totally untrusted on this.
- Radioactive waste permit denial has passed at least one of the chambers.
