Cindy Weehler, Co Chair 285 Alliance and member of Stop WIPP Forever

- There seems to be a collected amnesia about nuclear waste
- Holtec
 - Commercial waste repository that a private company wanted to bring to NM.
 - Waste to NM 100 tons to leave it here a little while.
 - Problem is that at the end of their license, they will walk away and we will have stranded waste.
 - This happened in Texas where the gov signed and said NO! . Went to court and is still in court.
 - 3 years have tried to get it through. SB 53 says that no facility like this can come unless NM consents.
 - Bill appoints a task force and oversees things; the Feds can put it wherever they want every state has ways to get around it.
 - NM we may not be able to control the Feds can't take that away from us. This bill denies Holtect permits. Holtec won't be able to build containers and other things.

- Holtec is commercial: all the waste from nuke. It's called high level waste and the worst. They want to bring by rail
- WIPP
 - nuclear weapons waste and not as bad as Holtec but...
 - Transuranic waste this is WIPP. This is all man made and radioactive.
 - It's mostly plutonium 239. Not immediately radioactive as the high level waste.
 - Other countries call this high level. We call it True Waste.
 - Won't bother your hand if you hold it but can cause if inhaled.
 - Plutonium at WIPP is diluted. Mixed up with the materials (clothing tools sludges, etc.) Smaller parts per amount. Pure P is not allowed.
 - P239 is a huge part of nuke waste. 239 is an isotope.
 - DOE is violating state and fed law by changing dates.
 - Several facilities are or proposed
 - WIPP in operation since 1999 and close to Carlsbad.
 - Original WIPP mission :
 - Only operating underground nuke repository in US. No commercial. When NM negotiated with Fed it included limits.
 - WIPP is pilot plant that is supposed to be one of many around the country.
 - Volume is limited down to the cubic foot. 6. 2 million cubic feet. Rooms are the length of 3 football fields. They were supposed to stop taking waste in 2024.
 - Only can take transuranics. Mostly P.
 - WIPP takes P that is contaminated from Nuke Weapons.
 - Does not take a nuke pit. It contains pure metallic.
 - These limits are still in place.
 - To LANL to waste route to 285 down to WIPP.. LANL packages the waste and places into a panel. Designed to protect the drums from traffic accidents.
 - How do we know that DOE has changed the mission?
 - Fed Registry: DOE published a notice of intent. Recently released an environmental impact program. They haven't spoken about it publicly.
 - We haven't gotten the DOE and NNSS publicly issued new permit request.
 - increase volumed is a concern
 - DOE wants to build out WIPP and this will be twice as large.
 - How can they build out in time for 2024. New permit has not date 2083?
 - Most of this waste is at Pantex. Truck to LA for processing. Then to Savana River Site for more processing. And then back somewhere.
 - No longer legacy waste. It will be pure P from the pits.
 - Pantex to LA (through SANTA FE). It is oxidized to P powder.
 - Comes back to LA. 5 pueblos. Passes farms and ranches
 - . When it gets to Amarillo. 11 states. For more than 50% not to be True Wast
- Office of secure transportation. Somewhat reinforced. LA Times 2017 wrote a story about the state of the trucks and the drivers. No \$. High level member of this depart said you have something to be concerned about.
- Sandia Labs said that particulate P almost impossible to clean up. . Have to be abandoned.
- Health effects: so fine and silty. If released it is quickly carried into lungs. Gets lodged in lung tissue. Cancer of the liver, lungs, bones, brain and gonads.

- Int'l Physicians for for the Prevention of Nuke War says that this causes cancer 100% of the time if inhaled. This would be a problem for emergency crews.
- Packaging. 1, first metal container. 2, then in a plastic bag, and then in another container. They are finding that the plastic bags degrade.

What promises has DOE broken?

- 1. No re's built wi other states
- 2. Volume increased
- 3. No date for end
- 4. Analyzing risk? Volume,, time, distance and your waste is more dangerous then as adults, we know that accidents happen. Will be catastrophic.

What to do?

- Build more R's near the waste
- Make DOE follow the laws. NM needs to say no.
- Clean up problems as LANL
- Fed wants to make 30 P pits in LANL and 50 in SC. Why make more when we can't handle what we have.
- If this is released, you can't go out. Shelter in place.
- Right now, transportation **is** the biggest issue.
- To the point, why don't you keep it where it is? I can speak to how it affects me. So I have standing.
- What would protect people? An N 95 might do it. High level waste shoots through your body.
- Tuesday's meeting -need people to come in person!!!!
- Permit has been presented to NM environ dept. DOE has asked. We are trying to get Environmental Dept to say no.
- NM Environ Website the person who tells them what to do is the Gov.
- Press conf last year March 1 delivered petitions. Gov sent a letter to Jennifer Granholm who said these are my constituents and you need to do something.
- This Feb we went to Roundhouse with a name of the towns affected.
- Making videos messages to Gov. Long stream running tomorrow night.
- Chris analysis of cost to move it from LANL. LANL is the only place to do the processing.
- Gloria -if their contract expires next year? Where does the legacy waste go? We think it should go to WIPP. Legacy waste is under tarps in forests.
- But it has to go somewhere? Some of the waste comes from other states. The Permian Basin is the third largest place in the world.
