- -Top: repealing and replacing the anti donation clause. Been attempted lots of times. Relic from colonial past where we tried to save \$. Gives the ability to donate to non profits. Repeal of it and allow us to have donations in a public purpose. Once concern is tribal nations. Not just repeal and replace, there will be enabling. State Auditor says there is no abuse.
- -Why not? Schools couldn't give kids year old computers because of anti-donation. Exemptions confuse people.
- —In states that have rid this they have effective non profit service distribution.
- —Most non profits do a lot of work.
- -Doing this now will help orgs who will be losing \$ because of new federal.
- -Who will object? Status quo. Exemptions are always applied inequitable.
- -Lawyers don't like it.

2nd Priority

- -Gun Safety assault weapons, register of AR15s. Previous time, limiting rounds and how it works inside these weapons.

Home owners insurance using AI for the same purpose. Progressive stepped out this because of fire.

- —one time funding for water, i.e. Strategic Water
- —Banning hemp derivatives
- —Collective bargaining for cannabis workers
- —Suicide pilot UNM working on this.
- —Paris accord agreements that we stay on the part of states. We are the second largest producer of oil and gas. After Alaska
- -Our fund is \$58b. Next 15 years. Sovereign wealth fund. We want to divest out of oil and gas. Within 15 years, we won't be reliant on boom of oil and gas. We are getting more diversified. LFC is telling us this.
- —Since 2019 we've been in boom cycle because of O&G. But it's usual one funding. This is one the boom started.
- -Reinvesting these funds into our sovereign wealth funds since '19. Governed by State Auditor. Is NM set up well enough where Martinez's cuts were devastated? State Parks are still recovering. Can we be sure in perpetuity? That's the risk from investment, However, we've seen continued growth in these
- —The sovereign fund was started to help fund education.
- —Child custody have an old school consultant in family court not working for children. Lawyers in legislature are not doing anything. Andrea will see a lot of crime bills we have a revolving door for criminals. We need funding for DAs and court staff, etc.
- —LFC says we don't have to raid other funds because we will have the funds.
- —Is money going to funding for training for renewable. Sort of rocky.
- —Can Trump withhold federal funds? Is there \$ set aside for this? We experienced this is in 2016.
